To All Whom These Presents May Concern:

We, W. R. Wyatt, H. C. McCarley and S. P. Anderson, as Trustees of John Knox Presbyterian Church, of Greenville County SEND GREETINGS:

WHEREAS, I/we the aforesaid mortgagor (s) in and by my/our certain promissory note, in writing, of even date with these presents am/are well and truly indebted to FIRST FEDERAL SAVINGS & LOAN ASSOCIATION OF GREEN-No/100

VILLE, in the full and just sum of Sixteen Thousand, Four Hundred Fifty & / (\$ 16,450.00)

Dollars (or for future advances which may be made hereunder at the option of said Association, which advances shall not exceed the maximum amount stated herein and shall be evidenced by a subsequent promissory note or notes se-

cured hereby), said note to be repelld with interest at the rate specified therein in installments of

One Hundred Fifteen and 51/100 ----(\$ 115.51 ) Dollars upon the first day of each and every calendar month herestler in advance, until the full principal sum, with interest, has been paid, such monthly payments to be applied first to the payment of interest, computed monthly on the unpaid principal balances, and then to the payment of principal. The last payment on said note, if not paid earlier and if not subsequently

extended, will be due and payable 20 years after date. The note further provides that if at any time any portion solving principal or interest due thereunder shall be past due and unpaid for a period of thirty (30) days, or failure for comply with any of the By-Laws of said Association, or any of the stipulations of this mortgage, the whole amount due under said note, shall, at the option of the holder, become immediately due and payable, and the holder may sue thereon and foreclose this mortgage; said note turther providing for ten (10%) per centum attorney, if see beside all costs and expenses of collection, to be added to the amount due on said note, and to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by said note, reference being thereunto had, will more fully appear.

"BEGINNING at an iron pin on the northeasterly side of Shannon Drive, joint front corner Lots 9 and 10; and running thence N. 59-25 E. 196.5 feet to an iron pin; thence N. 34-33 W. 84.3 feet to an iron pin; thence N. 39-14 E. 49.2 feet to an iron pin on Lake Fairfield Drive; thence along Lake Fairfield Drive, S. 76-44 W. 223.2 feet to an iron pin; thence around the curve of the intersection of Lake Fairfield Drive and Shannon Drive, the chord of which is S. 23-04 W. 29.6 feet to an iron pin on Shannon Drive; thence along Shannon Drive, S. 30-35 E. 150 feet to an iron pin, the point of beginning; being the same property conveyed to us by Frank P.
