NOW, KNOW ALL MEN; That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagoe at any time for advances made to or for his account by the Mortgagoe, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, self and release unto the Mortgagoe, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the southeastern side of Malloy Street, near the City of Greenville, being shown as Lot No. 4, Block A, on plat of Sterling Annex, recorded in Plat Book C, page 81, and described as follows:

Beginning at a stake on the southeastern side of Malloy Street, 150 feet northeast from Valentine Street, corner of Lot No. 1; thence with line of Lots Nos. 1,2, and 3, South 42-50 East 146.6 feet to a stake; thence North 48-05 East 50 feet to stake; corner of Lot No. 5; thence with line of said lot North 42-50 west 146.32 feet to stake on Malloy Street; thence with the southeastern side of Malloy Street outh 48-25 west 50 feet to the beginning corner; this being the identical property deeded to the mortgagor by deed of Frank Jackson, dated March 2, 1945, of record in Volume 273, at page 2 in the R.N.C. office for Greenville Coutny, South Carolina.

The Mortgagor further covenants to warrant and forever defend all and singular the seld premises unto the Mortgagoe forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.
