BEGINNING at an iron pin on the Eastern side of South Main Street at the joint corner of the property of Cauble Estate and Carpenter Brothers and running thence S. 72-30 E. 152.5 feet, the major portion of which is through the center of a brick wall to pin on a 16 foot alley; thence with said alley, N. 17-30 E. 26.5 feet to pin in center of a 17 inch brick wall; thence through the center of said 17 inch brick wall, N. 72-30 W. 152.5 feet to pin on South Main Street; thence with the Eastern side of South Main Street, S. 17-30 W. 26.5 feet to pin at corner of Carpenter Brothers property, the point of beginning.
