"M.I. that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed theiron, situate, lying and being in the State of South Carolina, County of Greenville and being all of tract No. 4 and the southeasterly portion of tract No. 5 of the J. H. Trammell estate, tract No. 2 containing 56.35 acres more or less and having, according to a plat of the said Trammell estate prepared by W. J. Riddle, November 25, 1935, the following metes and bounds, towit:
