"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, ving and being in the State of South Carolina, County of Greenville, Butler Township, lying on the southeast side of the Pelham Cross-Roads Road about two miles south from Pelham, and having the following courses and distances, to-wit:

BEGINNING at a nail and stopper in the center of the said road, and runs thence with the D.F. Smith line, N. 53-10 E. 25 feet to an old iron pin; thence continuing with the same course for a total distance of 1029 feet to a stake on the said line; thence N. 14-25 E. 269 feet to a nail and stopper in the center of another road (the Loop Road, iron pin back on line at 20 feet); thence with the center of the said road, S. 65-14 W. 375 feet to a bend; thence S. 61-29 W. 300 feet to a bend; thence S. 64-37 W. 100 feet to a bend; thence S. 74-11 W. 100 feet to a bend; thence S. 84-51 W. 100 feet to a bend; themce S. 87-26 W. 300 feet to a point in the center of the said road (in front of home now or formerly of Rufus B. and Louise G. Atkins); thence S. 80-00 W. 213 feet to a nail and stopper in the center of the coss roads; thence with the center of the first named road, S. 49-00 E. 673.5 feet to the beginning corner, containing 9.58 acres, more or less.
