Together with the appurtenances and all the estate and rights of the said Mortgagor in and to said premises.

And it is covenanted and agreed by and between the parties hereto that all gas and electric fixtures, radiators, heaters, engines and machinery, boilers; ranges, elevators, and motors, bath-tubs, sinks, water-closets, basins, pipes, faucets and other plumbing and heating fixtures, mirrors, mantels, refrigerating plant and ice-boxes, cooking apparatus and appartenances, and such other goods and chattels and personal property as are ever furnished by a landlord in letting or operating an unfurnished building, similar to the one herein described and referred to, which are or shall be attached to said building by nails, screws, bolts, pipe connections, masonry, or in any other manner, are and shall be deemed to be fixtures and an accession to the freehold and a part of the realty as between the parties hereto, their heirs, executors, administrators, successors and assigns, and all persons claiming by, through or under them, and shall be deemed to be a portion of the seemity for the indebtedness herein mentioned and to be covered by this mortgage.

To have and to hold the said promises and every part thereof with the appurtenances unto the said Mortgagee, its successors, legal representatives and assigns forever.

Provided always, that if the said Mortgagor, his many executors, administrators, successors or assigns shall pay unto the said Mortgagor, its successors or assigns, the said sum of money mentioned in the condition of the said not are abligations and the interest thereon, at the time and in the manner therein specified, then these presents in the condition of the said not are successors or assigns, the said sum of money mentioned in the condition of the said not are successors or assigns.

And it is further covenanted and agreed that the whole of said principal sum and the interest shall become due, at the option of the said Mortgagee upon failure of any owner of the above describes com-

ises to comply with the requirements of any Department of the City of Greenville, County of Greenville and or State of South Carolina
