That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assignas:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon situate, lying and being in the State of South Carolina, County of Greenville, Greenville Township, on the south side of West Earle Street and being known and designated as Lot "K" on Map 3 of the lands of Mountain City Land and Improvement Company, recorded in R.M.C. Office for sated county in Deed Book WW at Page 605, having according to plat thereof by Dalton & Neves, Engineers, August, 1926, the following metes and bounds:

BEGINNING at a stake on the south side of West Earle Street, which stake is 100 feet east of the southeast intersection of Townes and West Earle Streets, and running thence along West Earle Street-S. 84-30 E. 50 feet to stake; thence S. 5-30 W. 150 feet to stake; thence N. 84-30 W. 50 feet to stake; thence N. 5-30 E. 150 feet to stake at point of beginning

Being the same property conveyed to Edgar C. Waldrop by deed recorded in Deed Book 271 at Page 366; Edgar C. Waldrop died testate on July 29, 1946 and by his Will filed in Apartment 180 at File 11, authorized the trustees to execute mortgages and this mortgage is executed pursuant to this authority.
