All that certain piece, parcel or lot of land, with all imprograments thereon, or hereafter constructed thereon, situate lying and being in the State of South Carolina, County of Greenville, being shown as the greater portion of lot no. 74 on plat no. 2 of Sunset Hills, made by Dalton & Neves, Engineers, December, 1945, recorded in the RMC Office for Greenville County, S. C., in plat book "P" at pages 18 & 19 and having a coording to said plat, the following metes and bounds to-wit:

BEGINNING at an iron pin on the Northeast side of Sunset Drive at joint front corner of lots 73 & 74 and runs thence along the northeast side of Sunset Drive S 41-10 E, 96 feet to an iron pin; thence along line of propery now or formerly of J. R. Jenkinson Estate, N 55-30 E, 176.15 feet to an iron pin on the southwest edge of a five foot strip of land reserved for utilities; thence along the southwest edge of the five foot strip of land reserved for utilities, N 41-10 W, 106.1 feet to an iron pin in the rear line of lot 74, said pin being located 10 feet in a southeasterly direction from the joint rear corner of lots 72 & 74; thence in a straight line in a southwesterly direction 175 feet, more or less to an ironpin on the northeast side of Sunset Drive at joint front corner of lots 73 & 74 the point of beginning.
