All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed differeon, situate, lying and being in the State of South Carolina, County of Greenville, on the East side of Buckingham Road, in the City of Greenville, being shown as Lot No. 236 on plat of Section B of Gower Estates; made by R.
