To All Whom These Presents May Concern:

We, B. S. Buchanan and Lois S. Buchanan, of Greenville County,

SEND GREETINGS:

WHEREAS, I/we the aforesaid mortgagor(s) in and by my/our certain promissory note, in writing, of even date with these presents am/are well and truly indebted to FIRST FEDERAL SAVINGS & LOAN ASSOCIATION OF GREEN-

VILLE in the full and just sum of Sixteen Thousand. Eight Hundred & No/100 (\$16,800.00) Dollars (or for justice advances which may be made hereunder at the option of said Association, which advances shall not exceed the maximum amount stated herein and shall be evidenced by a subsequent promissory note or notes se-

cured hereby), said note to be repaid with interest at the rate specified (herein in installments of

One Hundred Five and 70/100 - - - - - (\$ - 105.70 ) Dollars upon the first day of each and every calendar month hereafter in advance, until the full principal sum, with interest, has been paid such menthly payments to be applied first to the payment of interest, computed monthly on the unpaid principal balances, and then to the payment of principal. The last payment on said note, if not paid earlier and if not subsequently

extended, will be due and payable 25 years after date. The note further provides that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thity (30) days, or failure to comply with any of the By-Laws of said Association, or any of the stipulations of this mortgage, the whole amount due under said note, shalf, at the option of the holder, become immediately due and payable, and the holder may sue thereon and foreclose this mortgage; said note further providing for ten (10%) per centum attorney's fee, beside all costs and expenses of collection, to be added to the amount due on said note, and to be collectible as a part thereof, if the same be placed in the hands-of an attorney for collection, or it said debt, or any part thereof, be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by said note, reference being thereunto had, will more fully appear.

NOW KNOW ALL MEN. That I/we, the said mortgagor(s) in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, according to the terms of said note, and also in consideration of the further, sum of Three Bollars to me/us the said mortgagor(s) in hand well and truly paid by the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, at and before the signing of these presents (the receipt whereof is hereby acknowledged), have granted bargained, sold and released, and by these presents do grant, hare granted bargained, sold and released, and by these presents do grant, bargain, self and release unto the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, the following described property, to-wit:

"All that certain piece, parcel or lot of fand, with all improvements thereon, or to be constructed there on, situate, lying and being in the State of South Carolina, County of Greenville, in Growe Township, containing eight (8) acres, more or less, according to a plat of property made by C. O. Riddle, Registered Land Surveyor, on February 10, 1962. This land is located on the south side of S. C. Highway #106 and according to plat recorded in Plat Book AAA, Page 109, having the following courses and distances, to-wit:

"BEGINNING under bridge at center of Grove Creek and intersection of Highway #106 and running thence S. 4-51 W. 698.1 feet to iron pin; thence N. 75-46 W. 451.8 feet to iron pin; thence N. 4-05 E. 814 feet to center of Highway; thence S. 71-09 E. 74.2 feet along center of said road; thence S. 65-28 E. 100 feet along center of said road; thence S. 61-06 E. 100 feet along center of said road; thence S. 59-10 E. 221.8 feet along center of gaid road to beginning point under bridge at center of creek. This land is bounded by lands of C. D. Griggs on the East and lands of J. W. Mahon on other boundaries; being the same property conveyed to us by James W. Mahon by his deed dated June 12, 1962 and recorded in the R.M.C. Office for Greenville County in Deed Vol. 700, at Page 399."
