The Mortgagor further aggrees that should this mortgage and the note secured hereby not be eligible for insurance under the National Housin Act within from the date hereof (written statement of any officer of the Federal Housing. Aministration or authorized agent of the Federal Housing Commissioner dated subsequent to the time from the date of this mortgage, declining to insure said note and this mortgage, being deemed conclusive proof of such ineligibility) the Mortgagee on the holder of the note may, at its option, declare all sums secured hereby immediately due and payable.

Should any legal proceedings be instituted for the foreclosure of this mortgage, or should the Mortgagee. become a party to any suit involving this mortgage or the title to the premises described herein or should the debt secured hereby or any part thereof be placed in the hands of an attorney at law for collection by suit or otherwise, all costs and expenses (including continuation of abstract) incurred by the Mortgagee, and a reasonable attorney's fee, shall thereupon become due and payable immediately or on demand, at the option of the Mortgagee, as a part of the flebt secured hereby, and may be recovered and collected hereunder.
