"All that certain piece, parcel of tot of land, with all improvements thereon, or hereafter constructed thereon, situate lying and being in the State of South Carolina County of Fickers, Greenville, in Oaklawn Townshp, containing 55 acres, more or less, and having according to plat of property of Mrs. N. N. Anderson Estate, recorded in Plat Book E at Page 109, the following metes and bounds, to-wit:
