"BEGINNING at an iron pin on the eastern side of Traynham Boulevard at the joint front corner of Lots #22 and #23 and running thence along joint line of said lots, N. 62-52 E. 170 feet to an iron pin in the line of Lot #24; thence along line of Lot #24, S. 40-10 E. 41.4 feet to an fron pin in the line of Lot #20; thence along line of Lot #20, S. 18-48 E. 60.2 feet to an iron pin at the joint rear corner of Lets #22 and #21 and running thence along joint line of said lots, S. 62-52 W. 170 feet to an iron pin on the eastern side of Traynham Boulevard; thence with the eastern side of said Traynham Boulevard, N. 27-08 W. 100 feet to the point of beginning; being the same property conveyed to us by George Peterson by his deed of even date to be recorded herewith. "

In addition to the above mentioned monthly payments of principal and interest payable under the terms of the note secured hereby, the mortgagor (s) agree (s) to pay to the mortgagee on the first day of each month until the note secured by this instrument is fully paid, the following sums: a sum equal to the premiums that will next become due and payable on policies of fire and other hazard insurance covering the mortgaged property, plustaxes, and assessments next due on the mortgaged property (all as estimated by the mortgagee) less all sums already paid thereforedivided by the number of months to elapse before one month prior to the date when such premiums, taxes, and assessments will be due and payable, such sums to be held by mortgages in escrow to pay said premiums taxes and special assessments.
