SEND GREETINGS:

WHEREAS, I/we the aforesaid mortgagor (s) in and by my/our certain promissory note, in writing, of even date with these presents am/are well and truly indebted to FIRST FEDERAL SAVINGS & LOAN ASSOCIATION OF GREEN-

VILLE, in the full and just sum of Fourteen Thousand and No/100 - - - - - - (\$14,000,00) Dollars (or for luture advances which may be made hereunder at the option of said Association, which advances shall not exceed the maximum amount stated herein and shall be evidenced by a subsequent promissory note or notes se-

cured hereby) said note to be repaid with interest at the rate engelified therein in installments of

One Hundred Six and 15/100-----(§ 106.15) Dollars upon the first day of each and every calendar month hereafter in advance, until the full principal sum, with interest, has been paid, such monthly payments to be applied first to the payment of interest, computed monthly on the unpaid principal balances, and then to the payment of principal. The last payment on said note, if not paid earlier and if not subsequently

extended, will be due and payable 18. years after date. The note further provides that if at any time any portion of the principal or interest due thereunder shalb be past due and unput for a period of thirty (30) days, or failure to comply with any of the By-Laws of said Association, or any of the stipulations of this mortgage, the whole amount due under said note, shall, at the option of the holder, become immediately due and payable, and, the holder may sue thereon and foreclose this mortgage; said note further providing for ten (10%) per centum attorney's fee beside all costs and expenses of collection, to be added to the amount, due on Isald note, and to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by said note, reference being thereunto had, will more fully appear.

NOW KNOW ALL MEN. "BEGINNING at an iron pin on the southern side of Swanson Court, the joint front corner of Lots Nos. 5 and 6, and running thence along the joint line of said lots, S. 33-00 W. 157.8 feet to an iron pin; thence S. 66-04 E. 86.4 feet to an iron pin at the rear corner of Lot No. 7; thence along the line of that lot, N. 33-00 E. 147.1 feet to an iron pin on the southern side of Swanson Court; thence along the southern side of Swanson Court, N. 57-00 W. 85 feet to the beginning corner; being the same conveyed to the mortgagor corporation by J.
