in the full and just sum of, One Thousand Six Hundred Sixty-Eight and 67/100 Dollars, in and by my certain promissory note in writing of even date herewith, due and payable on the day of \$268.67 on the 10th day of October, 1962, and \$100.00 on the 10th day of November, 1962, and \$100.00 on the 10th day of each successive month thereafter until paid in full

in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof, according to the terms of the said note, and also in consideration of the further sum of Three Dollars, to me in hand well and truly paid at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

D. E. Galway, his heirs and assigns forever:

All that lot of land in the County of Greenville, State of South Carolina, in Paris Mountain Township, known as Lot 13 and the western one-half of Lot 14, on plat of Block A, Hillendale Heights, recorded in plat book Y at page 61, and having the following metes and bounds, to-wit:

Beginning at an iron pin on the northwestern side of Crestline Road at the corner of Lot 12, thence N 55-21 W, 304 feet to an iron pin in the center of an 18-foot alley; thence with the center of said alley, N 13-15 E, 125.7 feet to an iron pin; thence with the center of said alley, N 27-50 E, 175 feet to the center of the rear line of Lot 14; thence S 29-44 E, 415 feet to an iron pin on the northwest side of Crestline Road; thence with the curve of said road, the chord of which is S 42-30 W, 37.5 feet; thence S 32-23 W, 75 feet to the point of beginning and being the same property conveyed to me in deed book 437 at page 227.
