WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

on the northern side of Linwood Avenue, near the City of Greenville, being shown as lot 49 on a plat of McSwain Gardens, recorded in Plat Book GG at Page 75, and described as follows:

BEGINNING at an iron pin on the northern side of Linwood Avenue, 158.2 feet West from McSwain Drive, at the corner of lot 50, and running thence with the line of said lot, N. 10-00 W. 178.1 feet to iron pin in line of lot 61; thence with lines of lots 51 and 52, S. 80-30 W. 99.3 feet to iron pin at the corner of lot 48; thence with line of said lot, S. 10-00 E. 167.8 feet to iron pin on Linwood Avenue; thence with the curve of the northern side of Linwood Avenue, the chords of which are N. 80-00 E. 7.2 feet and N. 86-59 E. 92.8 feet to the beginning corner.
