NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagoe at any time for advances made to or for his account by the Mortgagoe, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Oneal Township, near the Old Ansel School, about two miles north of the City of Green, lying on the southwest side of the Pollard Road, being shown on a plat of property made for T.C. Rollins by H.S. Brockman, Surveyor, dated June 21, 1958, recorded in the R.M.C. Office for Greenville County, and having the following courses and distances:

BEGINNING on a nail in the center of the Pollard Road (iron pin on southwest bank thereof), corner with property now or formerly owned by Loftis, and runs thence along the center of said road, S. 31-03 E. 274 feet to a nail, corner with the J. Calvin Paris lot (iron pin on southwest bank of road); thence with line of that lot, S. 82-12 W. 238 feet to an iron pin; thence S. 31-03 E. 210 feet to an iron pin on line of the Hargrove property; thence with Mrs. Hargrove's line, S. 89-30 W. 631 feet to an iron pin; thence N. 20-20 W. 66.2 feet to an iron pin; thence N. 87-15 W. 274.5 feet crossing branch to an iron pin; thence N. 19-36 W. 412 feet to an iron pin; thence N. 89-54 E. 1057 feet to the beginning corner, containing 10.98 acres, more or less.
