"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the of South Carolina, County of Greenville, City of Greenville, being known and designated as all of State of South Carolina, County of Lot No. 153 on Plat No. 3 of the Overbrook Land Company's and Woodside Investment Company's property, which Plat was prepared by R. E. Dalton, Engineer, in January 1924, and is recorded in the R. M. C. Office for Greenville County, S. C., in Plat Book "F", at page 218, and having, according to said Plat, the following metes and bounds, to-wit:
