SEND GREETINGS:

WHEREAS I the said Robert Searcy, Jr.

in and by my certain promissory note, in writing, of even date with these presents, am well and truly indebted to WOODRUFF FEDERAL SAVINGS AND LOAN ASSOCIATION in the full and just sum of SEVENTY-FIVE HUNDRED and no/100--- (\$7,500.00) Dollars,

with interest at the rate of six (6%) per centum per annum, to be repaid in installments of Sixty-three and 29/100--- (\$ 63.29) Dollars upon the first day of each and every calendar month hereafter until the full principal sum, with interest, has been paid.

Said monthly payments shall be applied first to the payment of interest, computed monthly on the unpaid balance, and then to the payment of principal; said note further providing that if at any time any portion of the principal or interest due thereunder shall be just due and unpaid for a period of thirty (30) days, or failure to comply with any of the By Laws of said Association, or any of the stipulations of this mortgage, the whole amount due under said note shall, at the option of the holder thereof, become immediately due and payable, who may sue thereon and foreclose this mortgage; said note further providing for a ten per cent attorney's fee besides all costs and expenses of collection, to be added to the amount due on said note, and to be collectible, as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by said note, reference being thereunto had, will more fully appear.

NOW KNOW ALL MEN That I the said Robert Searcy, Jr.

in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof in the said WOODRUFF FEDERAL SAVINGS AND LOAN ASSOCIATION, according to the terms of said note, and also in consideration of the further sum of Three Dollars to me the said

Office for said County, and having the following courses and distances, to-wit: Beginning at an Iron Pin in Memorial Drive Extension and which Iron Pin is at the joint front corner of lots nos. 2 and 3 as shown on said plat, and running thence with the joint property line of said two lots N. 22-27 E. 122.0 feet to an Iron Pin located at the joint rear corner of lots nos. 1 and 2 as shown on said plat, thence with the joint property line of said last two mentioned lots S. 52-15 E. 182.7 feet to an Iron Pin located at another joint rear corner of said lots nos. 1 and 2, thence S. 71-00 W. 152 feet to an Iron Pin in Memorial Drive Extension, thence with Memorial Drive Extension N. 63-30 W. 152 feet to the beginning point.
