MORTGAGE OF REAL ESTATE

per centum per annum; to be paid: annua lly from date

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purposes:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforestid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and fruly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and heing in the State of South Carolina, County of Greenville, and known as Lot No.27, shown on Plat

of Property prepared for N.M. Cannon, recorded in the Office of the R.N.C. for Greenville County in Plat Book F, at page 199, in the City Limits of Green, and having the following courses and distances, to-wit:-

BECINNING at corner of Lot No. 26 on Buncombe Street and running thence N. 76-45 E. 50 feet to a pin; corner of Lot No. 28; thence S. 13 E. 150 feet to corner of Lot No. 38; thence S. 76-45 W. 50 feet to corner of Lots No. 26 and 39; thence N. 13.W 150 feet to Buncombe Street and the point of beginning.

This is the same property conveyed to us this date, by deed from W.F. DeYoung, Sr. and Loleita DeYoung, deed to be recorded herewith.

Together with all and singular rights, members, herditaments, and appurtenances to the same belonging in any way incident or appertaining, and of all the rents, issues, and profits which may arise or be had thereform, and including all heating, plumbing, and lighting vixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its heirs, successors and assigns, forever.

The Mortgagor covenants that it is lawfully seized of the premises hereinabove described in fee simple absolute, that it has good right and is lawfully authorized to sell, convey or encumber the same, and that the premises are free and clear of all liens and encumbrances except as provided herein. The Mortgagor further covenants to warrant and forever defend all and singular the said premises unto the Mortgagee forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.
