BEGINNING at an imon pin in a branch, a corner of the property now or formerly owned by Jackson, said iron pin being located South 60 Degrees 30 Minutes West 296.2 feet from a nail in the center of a paved highway which leads from Lake Lapier to Highway, No. 14, and running thence from said beginning iron pin in said branch and with the Jackson line North 60 Degrees 30 Minutes East to a nail in the center of said paved highway; thence with the center of said Highway South 21 Degrees 56 Minutes East 285 feet to a nail; thence still with the center of said Highway South 18 Degrees 45 Minutes East, 500 feet to an iron pin, a corner of the land now or formerly owned by Mayfield Pierce; thence leaving said Highway and running with the Pierce line four calls as follows: South 66 Degrees 30 Minutes West 241 feet, North 84 Degrees West 25 feet, North 68 Degrees West 136 feet, and South 70 Degrees West 117 feet to an old Poplar on the Eastern margin of the branch, a corner common to the property now or formerly owned by Mayfield Pierce, the remaining lands of Joe J.
