MORTGAGE OF REAL ESTATE

To All Whom These Presents May Concern:

Whereas: we, Martha B. Hiott and S. W. Hiott, Jr.,

(hereinafter referred to as Mortgagor) is well and truly indebted unto FARMERS BANK OF SIMPSONVILLE, S. C.

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Five Thousand and No/100----- Dollars (\$ 5,000.00) due and payable one year from date

with interest thereon from date at the rate of Five (5) per centum per annum to be paid Monthly

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose;

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Austin Township, located on the South East corner of Jones Avenue, adjoining other lands of the grantor, and having according to a survey and plat made by W. J. Riddle, Surveyor, on November 8, 1951, the following metes and bounds, to-wit:

BEGGING at an iron pin on the Northwest corner and running along Jones Avenue N. 80-41 E. 200 feet to an iron pin; thence S. 5-11 E. 162 feet to an iron pin; thence S. 71-29 W. 144.4 foot to an iron pin on Jones Avenue; thence N. 23-15 W. 190 feet along Jones Avenue to the beginning point.

The above described lot is a portion of the same lands conveyed to D. L. Bramlett by R. D. Jones by deed dated November 28, 1917, recorded in Greenville County R. M. C. Office, Volume 43, page 249; also by deed from R. D. Jones to D. L. Bramlett dated April 12, 1921, and recorded in Greenville County R. M. C. Office, Volume 71, page 473.

Together with all and singular rights, members, hereditaments, and appurtenances to the same belonging in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its heirs, successors and assigns, forever.

The Mortgagor covenants that it is lawfully seized of the premises hereinabove described in fee simple absolute, that it has good right and is lawfully authorized to sell, convey or encumber the same, and that the premises are free and clear of all liens and encumbrances except as provided herein. The Mortgagor further covenants to warrant and forever defend all and singular the said premises unto the Mortgagee forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.
