NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

on the southwestern side of Piney Mountain Road, being the southern portion of lot # 6A, according to a plat of the property of C. S. Chandler and Carl Long, recorded in the RMC office for Greenville County in Plat Book AA at Page 42, and being further described as follows:

BEGINNING at an iron pin on the southwestern side of Piney Mountain Road, at the corner of lot 6A, and the right-of-way of the P & N Railroad, and running thence along the said Railroad right-of-way, S. 73-24 W. 136 feet to iron pin; thence N. 12-45 W. 50 feet to iron pin in line of lot 6A; thence in a new line through lot 6A, N. 73-24 W. 136 feet to iron pin on the southwest side of Piney Mountain Road; thence along Piney Mountain Road, S. 14-46 E. 50 feet to the point of beginning.
