To All Whom These Presents May Concern: I, W.W. Edwards,

the Mortgagor(s), SEND GREETING: hereinafter called

with interest thereon from date at the rate of six per centum per annum, to be computed and paid annually until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; and in case said note should be placed in the hands of an attorney for suit or collection the Mortgagor(s) agrees to pay all costs and expenses including a reasonable amount as attorney's fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

All that parcel or lots of land in Oneal Township of Greenville County, South Carolina, located on the south side of Edwards Lake Road, near Berry's Mill, being all of Lots Nos. 2 and 3 on a plat of the property of W.W. Edwards by Terry T. Dill, Registered C.E., and having the following courses and distances, to-wit:

BEGINNING on an iron pin on the south side of said road, joint corner of Lots Nos. 3 and 4 on said plat, and runs thence with the common line of Lots Nos. 3 and 4, S. 30-49 E. 172.8 feet to an iron pin; thence S. 77 W. 250 feet to an iron pin; thence N. 74-19 W. 90 feet to an iron pin, corner of Lot No. 1; thence with the line of that lot, N. 8-10 W. 147.6 feet to an iron pin on the Edwards Lake Road; thence with the margin of said road, N. 85-10 E. 145 feet to an iron pin and N. 81 E. 119.5 feet to the beginning corner.
