"BEGINNING at an iron pin on the eastern side of Bond Street, joint front corner of Lots Nos. 15 and 16, and running thence along the joint line of said lots, S. 82-13 E. 177 feet to an iron pin at the joint rear corner of Lots Nos. 10 and 11; thence along the rear line of Lot No. 10, S. 9-30 W. 100.1 feet to an iron pin at the rear corner of Lot No. 17; thence along the line of that lot, N. 85-24 W. 180 feet to an iron pin on the eastern side of Bond Street; thence along the eastern side of Bond Street, N. 9-41 E. 4477 feet to an iron pin; thence continuing along the eastern side of Bond Street, N. 11-25 E. 65.3 feet to the beginning corner.
