TO ALL WHOM THESE PRESENTS MAY CONCERN:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of GREENVILLE; All that piece of land in Greenville County beginning at an iron pin on the West side of Kent Lane, the front joint corner lots #49 and 50, thence with the joint line of said lots s 33-10, West 175 feet to iron pin in line of lot # 33, thence North 1-50 West 75 feet to iron pin corner of lot # 48, thence with the line of said lot North 33-10, East 175 feet to iron pin on the West side of Kent Lane, thence with the West side of Kent Lane; s 1-50, East 75 feet to beginning corner.
