WHEREAS, the Mortgagor is well and truly indebted unto TRAVELERS REST FEDERAL SAVINGS AND LOAN ASSOCIATION OF Travelers Rest, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of **Two Hundred Fifty and no/100**

**DOLLARS (\$ 250.00**), with interest thereon from date at the rate of **seven (7%)** per centum per annum, said principal and interest to be paid as therein stated, and

Beginning at an iron pin on the west side of Lindburg Street at the joint front corner of Lots 10 and 11 and running thence with the line of Lot 10, N 64-11 W, 112.85 feet to an iron pin; thence N 38-40 E, 95 feet to an iron pin; thence S 51-20 E, 110 feet to an iron pin on the western side of said street; thence with said street, S 38-40 W, 60 feet to the point of beginning and being the same property conveyed to me in deed book 641 at page 280.
