(7) That the Mortgagor shall hold and enjoy the premiers above conveyed until there is a default under this mortgage or in the note secured becoby. It is the true meaning of this instrument that if the Mortgagor shall fully perform all the terms, conditions, and covenants of the mortgage, and on the content of the mortgage shall be utterly null and void; otherwise to remain in full force and virtue.
