(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Five Hundred (\$500.00)

as follows: \$150.00 on February 1, 1964 with all accrued interest to date: \$150.00 on February 1, 1965 with all accrued interest to date, and \$200.00 on February 1, 1966 with all accrued interest to date; with full rights of anticipation prior to maturity without penalty;

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagoe at any time for advances made to or for his account by the Mortgagoe, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, sold and released, and by these presents does grant, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, near the City of Greenville, being known and designated as Lot No. 147 on a plat of the property of Chestnut Hills, which plat is recorded in the R.M.C. Office for Greenville County in Plat Book GG, at page 35, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at a point on the eastern side of Farmington Road at the joint corners of Lots Nos. 147 and 148, and running thence S. 74-01 E. 150 feet to a point; thence S. 15-59 W. 82.2 feet to a point; thence N. 88-18 W. 154.8 feet to a point on the eastern side of Farmington Road; thence with said road N. 15-59 E. 120.8 feet to the point of beginning.

It is specifically understood that this is a second mortgage over the above described property.

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its heirs, successors and assigns, forever.

The Mortgagor covenants that it is lawfully seized of the premises hereinabove described in fee simple absolute, that it has good right and is lawfully authorized to sell, convey or encumber the same, and that the premises are free and clear of all liens and encumbrances except as provided herein. The Mortgagor further covenants to warrant and forever defend all and singular the said premises unto the Mortgagoe forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.
