NOW KNOW ALL MEN, That II/we, the said mortgagor(s) in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, according to the terms of said note, and also in consideration of the further sum of Three Dollars to me/us the said mortgagor(s) in hand well and truly paid by the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, at and before the signing, of these presents (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, the following described property, to-wit:

"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, within the corporate limits of the City of Greenville, being known and designated as Lot No. 9 of a subdivision known as Swanson Court as shown on a revised plat thereof prepared by C. "BEGINNING at an iron pin on the northern side of Swanson Court, joint front corner of Lots 9 and 10 and running thence with the joint line of said lots, N. 36-15 E. 107.5 feet to an iron pin; thence continuing N. 36-15 E. 12 feet, more or less, to a point in the center of Richland Creek; thence with the center of Richland Creek, following the meanders thereof, in a westerly direction, the traverse line of which is S. 52-35 E. 194.5 feet; thence leaving Richland Creek and running S. 38-45 W. 15 feet, more or less, to an iron pin; thence S. 38-45 W. 50 feet to an iron pin, joint rear corner of Lots 8 and 9; thence with joint line of said lots, M. 76-07 W. 78.7 feet to an iron pin, thence continuing with the joint line of said lots, S. 79-10 W. 58 feet to an iron pin on the northern side of Swanson Court; thence with Swanson Court, N. 40-40 W. 82.3 feet to the beginning corner; being the same property conveyed to me by Mauldin Construction Co. by its deed of even date to be recorded herewith."
