C. for Greenville County in Plat Book QQ, Page 21, and having according to said plat the following metes and bounds, towit:

BETINNING at an iron pin on the southeast side of Ridgecrest Circle, joint front corner of lots 45 and 46, and running thence along the joint line of said lots, S. 54-09 E., 229.2 feet to an iron pin, joint rear corner of lots 45 and 46; thence along the line of property now or formerly of Lloyd Hunt, N. 2-02 E., 380.1 feet to an iron pin, joint rear corner of lots 45 and 44; thence along the joint line of said lots; S. 49-45 W., 284.2 feet to an iron pin on the southeast side of Ridgecrest Circle, joint front corner of lots 45 and 44; thence along the southeast curve of Ridgecrest Circle, the chord of which is S. 31-15 E., 33.6 feet, and S. 1-15 W., 33.6 feet to the point of beginning.
