C., according to the terms of the said note, and also in consideration of the further sum of Three (\$3.00) the said mortgagor... in hand well and truly paid by the said mortgagee, at and before the sealing and delivery of these Presents (receipt of which is hereby acknowledged), have granted, bargained, sold and released, and by these Presents degrant, bargain, sell and release unto the said CTTIZENS BUILDING AND LOAN ASSOCIATION, Greer, S. C., its successors and assigns:

That certain lot, parcel or tract of land, with all improvements now constructed thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs Township, lying about two miles West from the City of Greer, on the West side of the Buncombe Road and on the South side of a road that leads therefrom to the Suber Mill containing Fifty-one (51) Acres, more or less, being all of Tract No. 5 on a plat of the W. L. and Mrs. W. L. (Corrie W.) Dillard Estate lands made by H. S. Brockman, N Surveyor, dated March 26, 1946, and having the following courses and distances as delineated thereon, to wit: -

BECINNING at a point in the center of the Buncombe Road on line of I. P. Few lands (stake on the west bank of road), and runs thence with I. P.
