TO ALL WHOM THESE PRESENTS MAY CONCERN: We, Bayliss Fursell Martin and Lanta Jean Martin,

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Rights, Greenville, being the portion of a 7.31 acre tract measuring 219 feet by 110 feet at the southeastern corner of said tract, and according to plat of John C. Smith, Surveyor, dated April 22, 1959, being more fully described as follows: BEGINNING at the southeastern corner of the 7.31 acre tract, running thence along line of lands, of Albert Turner South 70-30 West 219 feet; thence North 19-05 West 110 feet; thence North 70-30 East 219 feet to point in a road; thence with the road South 7-55 East 110 feet to the BEGINNING corner; being the same land conveyed to Bayliss Fursell Martin and Lanta Jean Martin by J.
