That he will keep all improvements now existing or hereafter erected upon the mortgaged property in good repair, and in the case of an advance for construction, that he will continue construction until completion with out interruption, and should he fail to do so, the Mortgagee may, at its option, enter upon said premises, make whatever tepairs are necessary, including the completion of any construction work underway, and charge the expenses for such repairs or the completion of such construction to the mortgage debt.
- That the Mortgagee may require the maker, co-maker or endorser of any indebtedness secured hereby to carry life insurance upon himself in a sum sufficient to pay all sums secured by this mortgage, designating the Mortgagee as beneficiary and assignee thereof, and, upon failure of the Mortgager to pay the premiums therefor, the Mortgagee may, at its option, pay said premiums, and all sums so advanced by the Mortgagee shall become a part of the mortgage debt.
