aforesaid, and for the better securing the payment thereof, according to the terms of the said note, and  
also in consideration of the further sum of Three Dollars, to us in hand well and truly paid at and before  
the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, have granted,  
bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said  
W. Hart Miller, and Maude H. Miller, their heirs and assigns forever,

ALL that piece, parcel or lot of land with all improvements  
thereon situate in the County of Greenville, State of South Carolina,  
on the Northern side of a turn-around located at the Northeastern  
terminus of New Street, being shown as LOT NO. 2 on a plat of the  
property of Juanita W. Patrick recorded in Plat Book HH, at page 1 and  
according to said plat, being more particularly described as follows:

BEGINNING at an iron pin on the Northern side of turn-around  
above referred to at the front corner of Lot 1 and running thence with  
the curve of the Northern side of said turn-around, the chord of which  
is South 86-48 East 57.2 feet to an iron pin at the front corner of Lot 3;  
thence with the line of said lot, North 37-36 East 40.9 feet to an iron
