Township, being known and designated as Lot No. 14 of FORREST HILLS, a development of the Greer Community Post of the American Legion #115 according to survey by J.Q. Bruce, Registered Surveybr, prepared in October, 1955, and recorded in the R.M.C. Office for Greenville County in Plat Book "VV" page 59. For a more particular description, reference is hereby made to said plat and record thereof.
