SEND GREETINGS:

WHEREAS, I/we the aforesaid mortgagor(s) in and by my/our certain promissory note, in writing, of even date with these presents am/are well and truly indebted to FIRST FEDERAL SAVINGS & LOAN ASSOCIATION OF GREEN-

VILLE, in the full and just sum of <u>Five Thousand</u>, <u>Two Hundred and No/100---(\$ 5,200.00</u>) Dollars (or for future advances which may be made hereunder at the option of said Association, which advances shall not exceed the maximum amount stated herein and shall be evidenced by a subsequent promissory note or notes se-

cured hereby), said note to be repaid with interest at the rate specified therein in installments of

Forty-Three and 89/100-----(\$ 43.89 ) Dollars upon the first day of each and every calendar month hereafter in advance, until the full principal sum, with interest, has been paid, such monthly payments to be applied first to the payment of interest, computed monthly on the unpaid principal balances, and then to the payment of principal. The last payment on said note, if not paid earlier and if not subsequently

extended, will be due and payable 15 years after date. J. Riddle, December, 1943, recorded in the R. M. C. Office for Greenville County in Plat Book M, at Page 85, and having, according to said plat, the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the western side of Flora Avenue, corner of Lot No. 52,4 and running thence along the line of that lot, N. 60-51 W. 204.7 feet to an iron pin, joint rear corner of Lots Nos. 52 and 15; thence along the line of Lot No. 15, N. 27-40 E. 80.7 feet to an iron pin at the joint rear corner of Lots 53 and 54; thence along the line of Lot 54, S. 60-51 E. 219 feet to an iron pin on the western side of Flora Avenue; thence with the western side of Flora Avenue, S. 37-11 W. 81 feet to the point of beginning; being the same conveyed to me by S.
