WHEREAS, I/we the aforesaid mortgagor(s) in and by my/our certain promissory note, in writing, of even date with these presents am/are well and truly indebted to FIRST FEDERAL SAVINGS & LOAN ASSOCIATION OF GREEN-

VILLE, in the full and just sum of Six Thousand and No/100 -Dollars (or for future advances which may be made hereunder at the option of said Association, which advances shall not exceed the maximum amount stated herein and shall be evidenced by a subsequent promissory note or notes se-

cured hereby), said note to be repaid with interest at the rate specified therein in installments of

45.49 Forty-Five and 49/100 - - - - - - - - (\$\frac{45.49}{25.49}\$) Dollars upon the first day of each and every calendar month hereafter in advance, until the full principal sum, with interest, has been paid, such monthly payments to be applied first to the payment of interest, computed monthly on the unpaid principal balances, and then to the payment of principal. "BEGINNING at an iron pin on the western side of Oakvale Drive, joint corner of Lots 30 and 31; running thence along the joint line of said lots, N. 71-38 W. 200 feet to an iron pin; thence N. 18-30 E. 60 feet to an iron pin; thence S. 71-38 E. 200 feet to an iron pin on the western side of Oakvale Drive; thence along the western side of Oakvale Drive, S. 18-30 W. 60 feet to the beginning corner; being a portion of the property conveyed to the mortgagor corporation by Glens Falls Insurance Company by deed dated March 1, 1957 and recorded in the R.M.C.
