NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagoe at any time for advances made to or for his account by the Mortgagoe, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Township of Grove, containing Two and Ninety Seven one hundreth (2.97) acres, more or less, adjoining lands now or formerly owned by Duff Jameson, lands of Mrs. Elizabeth Anders, and lands now or formerly owned by Donia May Bennett, more fully described as follows: BEGINNING at corner on public road (N. W. corner of lands hereby conveyed) thence along line of Mrs. Elizabeth Anders 12.25 chains to iron pin NX: thence S-60-1/8 W. 4.88 to iron pin NX; thence N-71-3/4-W. 2.23 to iron pin NX: thence N-85-1/2-W-1.91 to aforesaid road; thence along said road to beginning corner 2.70.
