"BEGINNING at an iron pin on the southern side of Estanolle Street as shown on said plat, at the corner common to Lots Nos. 36 and 50, and running thence North 70-16 East along the said Estaholle Street, One Hundred Twenty-six and 5/10 feet to a stake; thence continuing along said Estanolle Street, North 79-03 East Twenty-four feet to the corner of Lot No. 49; thence along the dividing line between Lots Nos. 49 and 50, South 15-53 East Two Hundred feet, more or less, to a stake in the center line of a certain Creek shown on said plat; thence following the center line of said Creek in a southwesterly direction, a traverse line of which runs South 64- 99 West, One Hundred Ten and 7/10 feet to a stake at the corner of Lot No. 36; thence along the dividing line between Lots Nos. 50 and 36, North 26-46 West, Two Hundred Seventeen feet, more or less, to the place of beginning on Estanolle Street; being the same conveyed to me by George J./Jacobson by deed dated March 15, 1961 and recorded in the R. M. Q. Office for Greenville County in Deed Vol. 670, at Page 207."
