To ALL WHOM THESE PRESENTS MAY CONCERN:

ROBERT M. HENDERSON and IRENE L. HENDERSON  
Greenville County, S.C., hereinafter called the Mortgagor, send(s) greetings:

WHEREAS, the Mortgagor is well and truly indebted unto General Mortgage Co.

organized and existing under the laws of South Carolina, hereinafter called the Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which are incorporated herein by reference, in the principal sum of Twelve Thousand, Three Hundred Fifty and no/100 Dollars (\$ 12,350.00 ), with interest from date at the rate of Five and one-fourth per centum ( 5 1/4 %) per annum until paid, said principal and interest being payable at the office of General Mortgage Co. in Greenville, S. C.

or at such other place as the holder of the note may designate in writing, in monthly installments of Seventy-Four and 10/100 ----- Dollars (\$ 74.10 ), commencing on the first day of June, 1963, and on the first day of each month thereafter until the principal and interest are fully paid, except that the final payment of principal and interest, if not sooner paid, shall be due and payable on the first day of May, 1988.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its successors and assigns, the following-described real estate situated in the County of Greenville, State of South Carolina:

ALL that lot of land with the buildings and improvements thereon situate on the West side of Donnon Road (formerly Edwards Road) near the City of Greenville, in Greenville County, South Carolina, being shown as Lot No. 46 and a portion of Lot No. 47 on Plat of Property of W. S. Bradley made by Dalton & Neves, Engineers, April, 1945, recorded in the R.M.C. Office for Greenville County, S. C., in Plat Book O, Page 169, and having, according to said plat, the following metes and bounds to-wit:

BEGINNING at an iron pin on the West side of Donnon Road at joint front corner of Lots Nos. 45 and 46 and runs thence along the line of Lot No. 45, N. 88-10 W., 342 feet to an iron pin; thence S. 1-50 W., 120 feet to an iron pin in the rear line of Lot No. 47; thence through Lot No. 47, S. 88-10 E., 142 feet to an iron pin; thence N. 1-50 E., 10 feet to an iron pin; thence S. 88-10 E., 200 feet to an iron pin on the West side of Donnon Road; thence along Donnon Road, N. 1-50 E., 110 feet to the beginning corner.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and equipment now or hereafter attached to or used in connection with the real estate herein described.

To HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its successors and assigns forever.

The Mortgagor covenants that he is lawfully seized of the premises hereinabove described in fee simple absolute, that he has good right and lawful authority to sell, convey, or encumber the same, and that the premises are free and clear of all liens and encumbrances whatsoever. The Mortgagor further covenants to warrant and forever defend all and singular the premises unto the Mortgagee forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.
