C., its successors and assigns:

That certain lot, parcel or tract of land, with all improvements now constructed thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, O'Neal Township, located about three miles northwest of the City of Green and on the south side of Brookdell Drive, being all of Lot. No. 5 as shown on a plat of property made for Fred J. Bishop by H. S. Brockman, Surveyor, dated November 5, 1957, recorded in Plat Book EE, page 156, R. M. C. Office for Greenville County, and having the following courses and distances, to-wit:

BEGINNING on a stake on the south side of Brookdell Drive, joint corner of Lots. Nos. 5 and 6 on said plat, and runs thence with the common line of these lots, S. 11-20 E. 216.9 feet to a stake on line of Lot. No. 8; thence S. 75-19 W. 128 feet. to a stake; thence N. 14-30 W. 217 feet to a stake on the south side of said street; thence therewith N. 75-30 E. 140 feet to the beginning corner.

The above described property is conveyed subject to certain convenants and restrictions as to buildings and use as shown by record thereof in Deed Book 589, page 13, in the R. M. C. Office for Greenville County, and amendments as shown in Deed Book 634, page 158, R. M. C. Office for Greenville County.
