WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagoe at any time for advances made to or for his account by the Mortgagoe, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the scaling and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and telease unto the Mortgagoe, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

known as lot No. 16 on a plat of the property of Lake Forest, Section I, recorded in Plat Book GG at Page 17, and described as follows:

BEGINNING at an iron pin on the northern side of Lake Fairfield Drive, joint front corner of lots Nos. 15 and 16, and running thence with the line of lot No. 15, N. 44-46 W. 183 feet to iron pin; thence N. 80-21 E. 39.6 feet to an iron pin, joint rear corner of lots Nos. 16 and 17; thence with the line of lot No. 17, S. 77-21 E. 169.5 feet to an iron pin on Lake Fairfield Drive; thence with said Lake Fairfield Drive, S. 37-04 W. 125.1 feet to the point of beginning.

Being the same premises conveyed to the mortgagors by Richard B. Weeks etal by deed to be recorded.

THE MORTGAGORS AGREE that after the expiration of ten years from the date hereof, the MORTGAGEE may at its option apply for mortgage insurance for an additional period of five years with the mortgage insurance company insuring this loan, and the MORTGAGORS agree to pay to the MORTGAGEE as premium for such insurance one-half of one per cent of the principal balance then existing.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
