NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure, the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the scaling and delivery of these presents, the receipt whereof is hereby acknowledged, has granged, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgange, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, of hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

on the western side of Florence Drive, in the Town of Simpsonville, being shown as lot 47 on a plat of Hunters Acres, recorded in Plat Book BB at Page 51, and described as follows:

BEGINNING at an iron pin on the western side of Florence Drive, at the corner of lot 48; and running thence with the western side of said Drive, S. 17-20 w. 31.8 feet and S. 1-0 w. 50 feet to iron pin at the corner of lot 46; thence with the line of said lot, N. 88-53 w. 191.5 feet passing an iron pin to the center of a branch; thence with the branch as the line, the traverse of which is N. 0-13 \pm . 155.7 feet to the corner of lot 48; thence passing an iron pin S. 68-30 \pm . 216 feet to the point of beginning.

Together, with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real-estate.
