WILLIAM D. OWINGS, JR. (Hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor, do hereby and truly indebted unto CAROLINA FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, Greenville, S. C. (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference; in the sum of Twelve Thousand Five Hundred and No/100ths DOLLARS (\$12,500.00), with interest thereon from date at the rate of six per centum per annum, said principal and interest to be paid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose, and

WHEREAS, the unpaid balance of said debt or debts, if not sooner paid, shall be due and payable, August 1, 1988

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that piece, parcel or lot of land, with all improvements thereon, hereafter constructed thereon, situated, being and being on the Southern side of Alice Farr Drive near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 117 as shown on a plat of Sections 1 and 2, Western Hills, prepared by Jones & Sutherland, Engineers, dated August, 1959, recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book CQ at pages 98 and 99, and having according to said plat the following metes and bounds:

BEGINNING at an iron pin on the Southern side of Alice Farr Drive at the joint front corner of Lots Nos. 116 and 117, and running thence with the line of Lot No. 116 S. 23-30 E. 174.1 feet to an iron pin; thence N. 65-21 E. 100 feet to an iron pin at the joint rear corner of Lots Nos. 117 and 118; thence with the line of Lot No. 118 N. 23-30 W. 171.4 feet to an iron pin on the Southern side of Alice Farr Drive; thence with the Southern side of Alice Farr Drive S. 66-30 W. 100 feet to the point of beginning.
