I, P. E. Bradshaw,
the Mortgagor(s), SEND GREETING:

NOW KNOW ALL MEN, That the said Mortgagor(s), in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said Mortgagee according to the terms of the said note, and also in consideration of the further sum of Three Dollars to the said Mortgagor(s) paid by the said Mortgagee at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said Mortgagee,

All those certain lots or parcels of land, with any improvements thereon, in Chick Springs Township, said County and State, and known and shown as Nos. 1, 2, 3 and 4 and 5; 6 and 7 and 8 and 9 of Section 1 of Gilreath Estates as shown by plat by Piedmont Engineering Service, July 1957, and recorded, and having the various courses and distances as shown by said plat; and subject to the recorded restrictions thereon.
