MORTGAGE OF REAL ESTATE COUNTY OF GREENVILLE To All Whom These Presents May Concern: I. J. B. Barksdale, of Greenville County, SEND GREETINGS: WHEREAS, I/we the aforesaid mortgagor(s) in and by my/our certain promissory note, in writing, of even date with these presents am/are well and truly indebted to FIRST FEDERAL SAVINGS & LOAN ASSOCIATION OF GREEN-

VILLE, in the full and just sum of Two Thousand, Seven Hundred and No/100- (\$2,700.60) Dollars (or for future advances which may be made hereunder at the option of said Association, which advances shall not exceed the maximum amount stated herein and shall be evidenced by a subsequent promissory note or notes se-

Thirty and 66/100------(\$ 30,66 ) Dollars upon the first day of each and every calendar month hereafter in advance, until the full principal sum, with interest, has been paid, such monthly payments to be applied first to the payment of interest, computed monthly on the unpaid principal balances, and then to the payment of principal. The last payment on said note, if not paid earlier and if not subsequently ances, and then to the payment of principal. The last payment on said note, it not paid earlier and it not subsequently extended, will be due and payable 10 years after date. The note further provides that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty (30) days, or failure to comply with any of the By-Laws of said Association, or any of the stipulations of this mortgage, the whole amount due under said note, shall, at the option of the holder, become immediately due and payable, and the holder may sue thereon and foreclose this mortgage; said note further providing for ten (10%) per centum attorney's fee beside all costs and expenses of collection, to be added to the amount due on said note, and to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by said note, reference being thereunto had, will more fully appear.

NOW KNOW ALL MEN, That I/we, the said mortgagor(s) in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, according to the terms of said note, and also in consideration of the further sum of Three Dollars to me/us the said mortgagor(s) in hand well and truly paid by the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, at and before the signing of these presents (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, the following described property, to-wit:

M. Furman, Jr., Surveyor, in 1922 and recorded in the R. M. C. Office for Greenville County in Plat Book F, at Page 68, and as revised by plat prepared by W. J. Riddle, March, 1941 and recorded in Plat Book M, at Page 4, and having the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the west side of Bridwell Avenue, joint front corner of Lots 68 and 69, and running thence along the joint line of said lots, S. 89-15 W. 110. feet to an iron pin at the joint rear corner of Lots Nos. 46 and 47; thence along the rear line of Lot No. 46, N. 0-45 W. 40 feet to an iron pin on the south side of Watson Street: thence along the south side of Watson Street, N. 89-15 E. 110 feet to an iron pin at the intersection of Watson Street with Bridwell Avenue; thence with the west side of Bridwell Avenue, S. 0-45 E. 40 feet to the beginning corner; being the same conveyed to me by Octavia DuPree Pridmore by her deed dated September 12, 1950 and recorded in the R. M. C. Office for Greenville County in Deed Vol. 419, at Page 475."
