All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, atc. lying and being on the Southern side of Havenhurst Drive, near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 72 as shown on a plat of Homestead Acres, Section II, prepared by Piedmont Engineering Service, dated April 26, 1963, recorded in the R.M.C.
