NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgage at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the scaling and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgageo, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, situate on the North side of Woodland Drive, Paris Mountain Township, designated as Tract 37 on a plat of Mountain View Acres, recorded in Plat Book I at pages 69 and 70, and having according to said plat, the following metes and bounds:

BEGINNING at an iron pin on the Northern side of Woodland Drive, at the joint front corner of Lots 37, 38 and 39, and running thence along the Northern side of Woodland Drive, S. 81-40 W. 100 feet to a pin; thence continuing with Woodland Drive, S. 74-34 W. 131.2 feet to a pin at corner of tract 36; thence with line of tract No. 36, N. 34-W. 59 feet to point in center of branch; thence with the center of said branch, the traverse of which is N. 68-20 E. 156feet to a point at corner of Lot 40; thence with the line of tracts 37, 38 and 40, S. 38-50 E. 645 feet to a pin on the Northern side of Woodland Drive, the point of Beginning.
