NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also, in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs Township, situated on the north side of Pennsylvania Avenue, in the City of Greer, being Lot No. 7 in Block "A" of the Robinson Subdivision according to survey and plat by H.C. Brockman, Surveyor, dated April 21, 1910, recorded in Plat Book "E", page 233, R.M.C. Office for Greenville County, and having the following courses and distances, to-wit:

BEGINNING at a stake on said Avenue, and running thence along said Avenue, S. 76-35 E. 70 feet to a iron pin; thence N. 16-31 E. 236.7 feet to a stake on the right-of-way of the R & N Railway; thence with said right-of-way, N. 77-15 W. 70 feet to a stake, corner of Lot No. 8; thence along the line of Lot No. 6, S. 16-35 W. 235.5 feet to the beginning corner, and being the same property conveyed to the mortgagors by W.K. Leslie, 7th day need to be recorded herewith.

ALSO, all that other certain parcel or lot of land adjoining that above described, and being Lot No. 8 in Block "A" of the said Robinson Subdivision, shown on a plat referred to above, and having the following courses and distances, to-wit:

BEGINNING at a stake on Pennsylvania Avenue and running thence N. 16-31 E. 236.7 feet to a stake on right-of-way of the R & N Railway; thence S. 71-15 E. 70 feet along said right-of-way to a stake; thence S. 16-29 W. 228 feet to a stake; thence N. 76-35 W. along Pennsylvania Avenue 70 feet to the beginning.
